- 2. If the account is not paid in full as agreed and NORTHEAST SPECIALTY INSULATIONS, INC. DBA POLY-CEL chooses to take legal recourse, Company promises to pay all costs and expenses of collection, including actual attorney's fees and costs and expenses and attorney's fees incurred upon appeal.
- 3. Company agrees to all the terms and conditions of sale of NORTHEAST SPECIALTY INSULATIONS, INC. DBA POLY-CEL. Company agrees this application shall in no way interfere with NORTHEAST SPECIALTY INSULATIONS, INC. DBA POLY-CEL ability to lien and/or encumber real property for unpaid invoices or product.

DBA POLY-CEL full authority to check or verify any information provided herein and to obtain credit reports from time to time on Company and any individuals listed on this application.
